### PAST LEGISLATIVE WINS FOR MPA

#### **NRT Prescriptive Authority**

Pharmacists are the only non-physician healthcare providers with independent prescriptive authority in their ability to prescribe nicotine replacement therapies.

#### Reimbursement for Services and PBM Regulations

As pharmacy services continue to expand, the MPA continues to fight for pharmacy reimbursement. We are also on the front lines of reigning in and regulating Pharmacy Benefit Managers (PBMs), pushing for increased transparency to ultimately decrease the cost of care for patients and the health care system.

#### Decreased the Vaccine Age Limitation

The MPA promoted pharmacies as increasing access to care for patients and the impact you have on increasing vaccination rates in your communities. The age limit for patients able to receive a vaccine from a pharmacist decreased from 12 years old to 7 years old.
